## Vital Statistics and Public Nursing Report:

The Vital Statistic and the Nursing Reports for March were submitted for Board review. (see attached report).

Adele asked for an update on the WIC move. Garen stated he is meeting with Commissioners Monday, April 19<sup>th</sup> as another attempt in moving agencies around in the Government Center to make free room for WIC to be under the same roof. A further update will be provided at the weekly leadership meeting.

Adele: Do we have a total number of Harrison County's administration of both first and second vaccine doses?

Garen showcased Ohio's public dashboard of vaccine reporting. In Harrison County, approximately 27.95% (roughly 4,203 individuals) received first doses whereas approximately 20.5% (roughly 3,095 individuals) completed the vaccine process.

Kent: Is the county using all the vaccine it receives?

Garen: In the last two weeks we have seen interest slow among eligible populations. After speaking with local individuals and peers, it seems some interest has declined due to hesitancy brought on by conspiracy theories. The department has approximately 700 doses of vaccine on hand in case another Ohio entity needs vaccine in an emergency.

# **Administration Report:**

Garen brought forward a request that the board approve a donation of an older model clinic fridge and freezer to Harrison Hills City School District.

Garen briefed the board on an opportunity to vaccinate sixteen- and seventeen-year-old individuals with the help of Change Inc. out of Wintersville. Change Inc. has a mobile unit they would bring to the county and conduct the entire vaccination process. The health department would provide letters and remaining paperwork to the schools.

The board was provided with a death rate chart from 1970 to 2020. Garen went over the data and shared how 2020 had a significant, and the highest total, death rate. Harrison County does have a Harrison County Substance Abuse Coalition that was gaining speed up until the pandemic. Teresa stated the Coalition still meets monthly, hoping to get traction and do more proactive things to help residents. Garen discussed Spring drug take-back days as effort to help residents get unused drugs from their homes.

Adele asked if the Harrison County Coalition is reaching out and working alongside the schools. Teresa confirmed Mrs. Dana Snider, HHCSD Superintendent, attends meetings. The Health Department and Harrison Hills have worked together regarding vaping and tobacco use.

Garen stated he and Teresa met with Laura Ott, current WIC employee, regarding her interest in acquiring more hours in the work week. With Erin McKenna being a full-time Infection Prevention RN, the possibility of Laura working more hours may take some workload off Teresa's shoulders.
